b. If approved, adopt and authorize the Chairman to execute the ordinances for CPA/AA-16-05, Clark A. Stillwell for State Road 44 Land Trust, amending the Future Land Use Map (Ordinance No. 89-04) and the Land Development Code Atlas (Ordinance No. 2012-06); and direct the Clerk to record the ordinances in the public records in Citrus County, Florida.
