3 A RESOLUTION OF THE MAYOR AND VILLAGE  
4 COUNCIL OF THE VILLAGE OF PALMETTO BAY,  
5 FLORIDA, RELATING TO AD VALOREM TAXES;  
6 ESTABLISHING THE PROPOSED MAXIMUM MILLAGE  
7 RATE AND SETTING THE DATES, TIMES, AND

13 WHEREAS, the Village has received the Certification of Taxable  
14 Value from the Miami-Dade County Property Appraiser; and,

16 WHEREAS, the Village is required under State Statutes to  
17 establish and furnish to the Property Appraiser the proposed maximum  
18 millage rate and the dates, times and location(s) at which public  
19 hearings will be held to consider the FY 2024-2025 millage rate and  
20 budget; and,

22 NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND  
23 VILLAGE COUNCIL OF THE VILLAGE OF PLAMETTO BAY,  
24 FLORIDA, AS FOLLOWS:

26 Section 1. The proposed maximum millage rate for the Village of  
27 Palmetto Bay for FY 2024-2025 is established at 2.350 mills, which is  
28 \$2.35 for each \$1,000.00 of assessed property within the Village of  
29 Palmetto Bay.
