CITY OF DADE CITY RESOLUTION NO. 2025-01

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF DADE CITY, FLORIDA, ADOPTING THE CITY OF DADE CITY WATER SYSTEM ASSET MANAGEMENT PLAN (2025); PROVIDING FOR THE IMPLEMENTATION OF ADMINISTRATIVE ACTIONS; PROVIDING FOR SEVERABILITY; PROVIDING FOR SCRIVENER'S ERRORS; CONFLICTS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City is responsible for ensuring its water services are able to support unprecedented growth while continuing to protect public health; and

WHEREAS, by adopting a Water System Asset Management Plan ("AMP"), which focuses on long-term planning over the next five to ten years, the City will continue to have the resources necessary to meet its goals and provide for the public health, safety and welfare; and

WHEREAS, the AMP adopted herein has been prepared in compliance with the U.S. Environmental Protection Agency and State Revolving Fund planning document requirements within the Florida Administrative Code; and

WHEREAS, the purpose of the AMP is to ensure that water utilizes efficiently manage their infrastructure assets over time and focuses on an inventory and assessment of assets for cost-effective maintenance and renewal, financial planning, risk management and reliability, sustainability and resilience, as well as aligning practices with environmental and regulatory compliance; and

WHEREAS, the City Commission finds that it is in the best interests of the health, safety, and welfare of the City's residents to adopt the AMP attached and incorporated herein at Exhibit "A"; and

WHEREAS, the City Commission intends to incorporate the AMP into its comprehensive plan at the time of the adoption hearing for its latest text amendments.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF DADE CITY, FLORIDA, AS FOLLOWS:

SECTION 1. <u>Legislative Findings and Intent</u>. The recitals set forth above are adopted as legislative findings and intent of the City Commission.

SECTION 2. Adoption of Water System Asset Management Plan (2025). The City Commission adopts the Water System Asset Management Plan (2025), following appropriate comment and public hearing, which is attached hereto as Exhibit "A." The City shall incorporate this plan into its comprehensive plan at the adoption hearing for its latest text amendments to the comprehensive plan. The AMP may be amended, when necessary, consistent with comments received from the Southwest Florida Water Management District, or any updates to the applicable regulations.

SECTION 3. <u>Directions to City Manager.</u> The City Manager of the City of Dade City is hereby authorized and directed to take such action as may be deemed necessary and appropriate to implement the provisions of this Resolution. The City Manager may, as deemed appropriate, necessary, and convenient, delegate the powers of implementation as set forth herein to such City employees as deemed effectual and prudent.

SECTION 4. <u>Severability</u>. If any section, sentence, clause, or phrase of this Resolution is held to be invalid or unconstitutional by any court of competent jurisdiction, then all remaining provisions and portions of this Resolution shall remain in full force and effect.

SECTION 5. Conflicts. All resolutions in conflict herewith are hereby repealed to the extent of such conflict.

SECTION 6. <u>Scrivener's Errors</u>. The administrative correction of typographical and/or scrivener's errors in this Resolution which do not affect the intent may be authorized by the City Manager or her designee, without the need of consideration by the City Commission, by filing a corrected copy of same with the City Clerk.

SECTION 7. Effective Date. This Resolution shall take effect immediately upon its passage.
