Subject Title: ORDINANCE 2025-04 AN ORDINANCE OF THE TOWN OF LAUDERDALE-BY-THE-SEA, FLORIDA, AMENDING CHAPTER 5, "BEACHES AND WATERWAYS," ARTICLE I, "IN GENERAL," SECTION 5-7, "FISHING REGULATED; EXHIBITING FISH ON BEACH AND SPEARFISHING PROHIBITED," OF THE TOWN'S CODE OF ORDINANCES; PROVIDING FOR CODIFICATION, SEVERABILITY, CONFLICTS, AND AN EFFECTIVE DATE.

Explanation: We have experienced a huge increase in the number of people fishing and surf casting on the beach. The current Code allows fishing and surf casting at any time other than the hours of 9 AM through 4 PM on weekdays and 9 AM through 6 PM on Saturday, Sunday, and holidays.

Persons are also prohibited from engaging in fishing and surf casting within the proximity of swimmers.

The problem that we have is that long stretches of the beach have been taken over by those who are fishing and surf casting, and beach goers cannot enjoy the beach. Most often, those who are fishing and surfcasting are present before the beach-goers arrive, so that they are not limited by the Code provision regarding proximity to swimmers.

Staff is suggesting amending the Code to allow surfcasting and fishing between the hours of 7 PM and 7 AM. This reduced time will still allow fishing and surfcasting from our beach, while allowing swimming, walking and the passive enjoyment of the beach for others.

Recommendation: Adopt Ordinance 2025-04 on first reading, and set second reading for April 22, 2025.

13	WHEREAS, the Town Commission of the Town of Lauderdale-By-The-Sea, Florida (the
14	"Town") finds it periodically necessary to amend its Code of Ordinances (the "Town Code") in
15	order to update regulations and procedures to implement municipal goals and objectives; and
16	WHEREAS, the Town seeks to ensure that all beach activities, including fishing and surf
17	casting, are conducted in a manner that minimizes conflicts, while providing a clearer and more
18	consistent schedule to promote safety and enjoyment for all users of the public beach; and
19	WHEREAS, the Town Commission desires to amend Chapter 5, "Beaches and
20	Waterways," Article I, "In General," Section 5-7, "Fishing Regulated; Exhibiting Fish on Beach
21	and Spearfishing Prohibited," of the Town's Code to revise the hours for fishing and surf casting
22	on the Town's public beach; and
23	WHEREAS, the Town Commission finds that this Ordinance is in the best interests of the
24	Town and its residents.
25 26 27	NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COMMISSION OF THE TOWN OF LAUDERDALE-BY-THE-SEA, FLORIDA, AS FOLLOWS:
28	Section 1. Recitals. The foregoing "Whereas" clauses are ratified and incorporated as
29	the legislative intent of this Ordinance

30	Section 2. Amendment. Chapter 5, "Beaches and Waterways," Article I, "In General,"
31	Section 5-7, "Fishing Regulated; Exhibiting Fish on Beach and Spearfishing Prohibited," of the
32	Town Code of Ordinances, is hereby amended to read as follows1:
33	CHAPTER 5 - BEACHES AND WATERWAYS
34	ARTICLE I IN GENERAL
35	Sec. 5-1 Definitions.
36 37	The following words and phrases, when used in this chapter, shall have the following meanings respectively ascribed to them except where the context clearly indicates a different meaning:
38 39 40 41	<i>Beach</i> means the zone of unconsolidated material that extends landward from the mean low waterline to the place where there is marked change in material or physiographic form or to the line of permanent vegetation, usually the effective limit of storm waves. Beach is alternatively termed shore.

43	Sec. 5-7 Fishing regulated; exhibiting fish on beach and spearfishing prohibited.
44 45	(a) It shall be unlawful for any person to spearfish on the public beach within the corporate limits of the Town.
46 47	(b) It shall be unlawful for any person to fish or surf cast from any part of the public beach within the corporate limits of the Town unless in compliance with the following:
48 49 50	(1) Fishing and surf casting shall be allowed on the public beach at any time other than the hours of 7:00 a.m. through 7:00 p.m. every day 9:00 a.m. through 4:00 p.m. Monday through Friday, and 9:00 a.m. through 6:00 p.m. on Saturday, Sunday and national holidays.
51 52	(2) Persons are prohibited from engaging in fishing and surf casting within the proximity of swimmers, scuba divers, snorkelers and bathers.
53	(3) Chumming is prohibited.
54 55 56	(4) The Town Manager or designee may temporarily place further restrictions on fishing or surf casting on any part of the public beach to accommodate an event taking place on the beach or in a declared emergency.
57 58	(c) It shall be unlawful for any person to use the beaches of the Town for the purpose of landing or exhibiting sharks, barracuda or sting rays.

61	Section 3. Codification. This Ordinance shall be codified in accordance with the foregoing
62	It is the intention of the Town Commission that the provisions of this Ordinance shall become and be
63	made a part of the Town of Lauderdale-By-The-Sea Code of Ordinances; and that the sections of thi
64	Ordinance may be renumbered or re-lettered and the word "ordinance" may be changed to "section"
65	"article" or such other appropriate word or phrase in order to accomplish such intentions.
66	Section 4. Severability. If any section, sentence, clause, or phrase of this Ordinance is held
67	to be invalid or unconstitutional by any court of competent jurisdiction, then said holding shall in no
68	way affect the validity of the remaining portions of this Ordinance.
69	Section 5. Conflicting Ordinances. All prior ordinances or resolutions or parts thereof in
70	conflict herewith are hereby repealed to the extent of such conflict.
71	Section 6. Effective Date. This Ordinance shall become effective upon adoption or
72	second reading.
